Previous Council Review Date:

Summary: In 2011, the Administrative Office of the Courts (AOC) requested records pertaining to courts from many jurisdictions for review. Upon review, the AOC noted potential issues with the City's ordinance. This amendment updates the PMC to comply with State law and court rules and gives the statutes that apply to each section.

Recommendation/Action: Adopt amendments to Pacific Municipal Code 2.24 as recommended by the Administrative Office of the Courts.

Motion for Consideration: I move to approve Ordinance No. 2016-1929, amending Pacific Municipal Code 2.24 to insert relevant statutory provisions and removing provisions that lack authority under state law.

Budget Impact: None

Alternatives: Leave the ordinance in place which has inconsistencies with State law and court rules.

ORDINANCE NO. 2016-1929

AN ORDINANCE OF THE CITY OF PACIFIC, WASHINGTON, RELATING TO THE MUNICIPAL COURT, UPDATING THE CODE TO INSERT RELEVANT STATUTORY PROVISIONS AND MAKING OTHER HOUSEKEEPING AMENDMENTS AND REMOVING PROVISIONS THAT LACK AUTHORITY UNDER STATE LAW; AMENDING PACIFIC MUNICIPAL CODE SECTIONS 2.24.010, 2.24.020, 2.24.030, 2.24.040, 2.24.050, 2.24.060, 2.24.065, 2.24.070 AND REPEALING SECTION 2.24.080.

WHEREAS, the City last updated Section 2.24.010 of the Pacific Municipal Code in Ordinance No. 762; and

WHEREAS, additional changes are required to comply with State law as well as court rules ;

IT IS HEREBY ORDAINED BY THE PACIFIC CITY COUNCIL AS FOLLOWS:

Section 1. Section 2.24.010 of the Pacific Municipal Code, as last amended by Ordinance No. 762, is hereby amended to read as follows:

2.24.010 Created – Judge – Appointment.

A. **Authority.** Pursuant to chapter 3.50 RCW, there is created and established an inferior court to be known and designated as a municipal court, entitled “The Municipal Court of the City of Pacific,” which court shall have exclusive original criminal jurisdiction of all other actions brought to enforce or recover license penalties or forfeitures declared or given by such city ordinances or by any state statutes. The municipal court shall have jurisdiction and shall exercise all power granted to it under the Revised Code of Washington, together with such other powers and jurisdictions as are generally conferred in this state by either common law or by express statute upon the municipal court.

B. **Judge.** The municipal court judge shall be appointed by the mayor, and confirmed by a majority vote of the city council. The person appointed as municipal judge shall be a citizen of the United States and the state. The position of such municipal judge shall be on a part-time basis.

C. Judge's appointment. Such appointment shall be for a term of four years. Appointment shall be made in a like manner by the fifteenth day of December preceding the end of every such four-year term.

Section 2. Section 2.24.020 of the Pacific Municipal Code is hereby amended to read as follows:

2.24.020 Judge's salary.

The salary of the municipal court judge shall be fixed by ordinance of the city council from time to time; RCW 3.50.080.

Section 3. Section 2.24.030 of the Pacific Municipal Code is hereby amended to read as follows:

2.24.030 Deposit of moneys collected.

All fees, costs, fines, forfeitures and other moneys imposed or collected by the municipal court for the violation of any municipal ordinance, together with any other revenues received by the municipal court, shall be deposited with the finance director as a part of the general fund of the city; RCW 3.50.100.

Section 4. Section 2.24.040 of the Pacific Municipal Code is hereby amended to read as follows:

2.24.040 Pleadings, practice and procedure.

Pleadings, practice and procedure in cases not governed by statutes or rules specifically applicable to municipal courts shall, insofar as applicable, be governed by the statutes and rules now existing including the applicable provisions of Title 3 RCW or as may hereafter be adopted governing the pleadings, practice and procedure applicable to district courts; RCW 3.50.450.

Section 5. Section 2.24.050 of the Pacific Municipal Code is hereby amended to read as follows:

2.24.050 Judge pro tem – Position established.

There is established a position to be known as judge pro tem, which judge pro tem shall act in the absence of the regular municipal judge of the city and shall have all of the powers and duties of the regular municipal judge; RCW 3.02.060.

Section 6. Section 2.24.060 of the Pacific Municipal Code is hereby amended to read as follows:

2.24.060 Judge pro tem – Appointment – Qualifications.

The presiding judge is hereby directed to appoint necessary judges pro tem to act in the absence or disability of the duly qualified municipal judge. The judges pro tem shall be qualified to hold the position of judge of the municipal court as provided for in PMC 2.24.010; RCW 3.50.090.

Section 7. Section 2.24.065 of the Pacific Municipal Code is hereby amended to read as follows:

2.24.065 Court administrator.

There shall be a court administrator of the municipal court appointed and removed by the municipal judge. The municipal court judge shall supervise and control the court administrator. The court administrator shall perform such duties as may be prescribed by law for a court administrator or a court clerk and shall perform such other duties as may be assigned by the municipal court judge. The court administrator shall be paid such compensation as the city council may provide from time to time; RCW 3.50.080.

Section 8. Section 2.24.070 of the Pacific Municipal Code is hereby amended to read as follows:

2.24.070 Court clerk.

There shall be a court clerk of the municipal court appointed and removed by the municipal court judge. The court clerk shall be supervised by the court administrator and shall perform such duties as may be assigned by the municipal court judge or the court administrator. The court clerk shall be paid such compensation as the city council may provide from time to time; RCW 3.50.080.

Section 9. Section 2.24.080 of the Pacific Municipal Code is hereby repealed.

Section 10. Severability. If any section, sentence, clause or phrase of this Ordinance should be held to be unconstitutional or unlawful by a court of competent jurisdiction, such invalidity or unconstitutionality shall not affect the validity or constitutionality of any other section, sentence, clause or phrase of this Ordinance.

Section 11. Publication and Effective Date. This Ordinance shall be published by an approved summary consisting of the title, and shall be effective 5 days after publication.

Regarding the Judge's term of office: original contains scrivener error and had been corrected

Regarding Judge Pro Tempore: The mayor has not exercised any authority nominally granted by PMC 2.24.060 while I (Stephen Rochon) have been Presiding Judge (since 1998). All Pro Tem Judges have been appointed by the PJ since then.

Regarding court administrator appointment: The City Council has never failed to confirm administrator appointments by the PJ.

Regarding costs under PMC 2.24.080: The costs ostensibly authorized by this provision have never been imposed by the Court.

This message has been forwarded on behalf of Dirk Marler, Director, Judicial Services Division, Administrative Office of the Courts.

Dear Judge Rochon:

This is a follow-up to my recent e-mail regarding the records that your city public records officer provided to the AOC in response to our February 2011 public records request (see "*Part-Time Municipal Courts in Washington, 2011*," Appendices 1, 2, 3).

We requested records pertaining to judicial salaries, terms of employment and the position of the court within the city government. I have attached an electronic copy of your city's response.

In reviewing the records for your city, we noted the following potential issues:

- The Judge's term of office does not coincide with the state standard provided in RCW 3.50.040 of a four-year term from 1/1/2010 – 12/31/2013.

- The Mayor is permitted to select the Judge Pro Tempore, in conflict with RCW 3.50.090 and GR 29(f)(12).
- The Court Administrator must be confirmed by the City Council, which appears to conflict with GR 29(f).
- The costs imposed under PMC 2.24.080 may lack authority under state law.

We acknowledge that the information AOC received may not be complete or current, and so leave to your discretion any decisions about changes that may be appropriate.

Summary:

Background

The State legislature has amended the statutory definitions related to medical marijuana. The State eliminated the regulations applicable to “collective gardens” but added provisions regarding medical marijuana “cooperatives” (Att. 2). These provisions become effective July 1, 2016.

Chapter 20.09 of the Pacific Municipal Code (PMC) prohibits medical marijuana collective gardens, etc. It does not currently prohibit cooperatives. If the City does not prohibit the cooperatives by July 1st, it may be required to allow a cooperative to be located in the City if a business license is issued by the State Liquor and Cannabis Board prior to the City prohibiting this use.

The proposed interim ordinance, if adopted by the Council at the June 13, 2016 Council meeting, would prohibit marijuana cooperatives prior to July 1, 2016. The City would continue to follow the procedures mandated by law to amend development regulations as provided in the Growth Management Act (GMA) and City codes.

Recommended Action:

Adopt Interim Ordinance 2016-1930.

AN INTERIM ZONING ORDINANCE OF THE CITY COUNCIL OF THE CITY OF PACIFIC, WASHINGTON, RELATING TO MEDICAL MARIJUANA, PROHIBITING MARIJUANA COOPERATIVES AS WELL AS COLLECTIVE GARDENS AND UPDATING THE DEFINITIONS RELATING TO MEDICAL MARIJUANA, IN ORDER TO CONFORM WITH RECENT LEGISLATIVE AMENDMENTS, THIS INTERIM ORDINANCE TO BE EFFECTIVE IMMEDIATELY, SETTING SIX MONTHS AS THE EFFECTIVE PERIOD OF THIS INTERIM ORDINANCE WHICH AMENDS PACIFIC MUNICIPAL CODE SECTIONS 20.09.020 AND 20.09.030, ESTABLISHING THE DATE OF A PUBLIC HEARING ON THE INTERIM ORDINANCE, DECLARING AN EMERGENCY AND PROVIDING FOR AN IMMEDIATE EFFECTIVE DATE.

WHEREAS, the City of Pacific prohibits both medical and recreational marijuana uses in PMC chapter 20.08 and chapter 20.09; and

WHEREAS, the federal government has not legalized marijuana and the Pacific City Council still desires that all marijuana uses be prohibited in the City of Pacific; and

WHEREAS, the City's codes relating to medical marijuana included definitions that were consistent with Washington state law at the time the codes were adopted; and

WHEREAS, since that time, the Washington State Legislature has amended the statutory definitions relating to medical marijuana in RCW 69.51A.010; and

WHEREAS, the Legislature has also eliminated the regulations applicable to "collective gardens" in RCW 69.51A.085, effective July 1, 2016; and

WHEREAS, the Legislature adopted provisions allowing medical marijuana "cooperatives" in RCW 69.51A.250, effective July 1, 2016; and

WHEREAS, in order to accomplish the City’s objectives in prohibiting medical marijuana uses in Pacific, this Ordinance needs to be effective prior to July 1, 2016; and

WHEREAS, after adoption of this Ordinance as an interim ordinance pursuant to RCW 36.70A.390, the City still plans to follow the procedures required by law for the amendment of a development regulation, as provided in the Growth Management Act and the City’s codes; Now, Therefore,

THE CITY COUNCIL OF THE CITY OF PACIFIC, WASHINGTON, ORDAINS AS FOLLOWS:

Section 1. Section 20.09.020 of the Pacific Municipal Code is hereby repealed.

Section 2. A new Section 20.09.020 is hereby added to the Pacific Municipal Code, to read as follows:

20.09.020 Definitions. For purposes of this chapter, the following definitions apply:

“Collective Garden” has the meaning set forth in RCW 69.51A.085.

“Cooperative” has the meaning set forth in RCW 69.51A.250.

“Cultivation” means the planting, growing, harvesting, drying or processing of marijuana plants or any part thereof.

“Deliver or delivery” means the actual or constructive transfer from one person to another of a substance, whether or not there is an agency relationship.

“Designated provider” has the meaning provided in RCW 69.51A.010.

“Dispense” means the interpretation of a prescription or order for medical cannabis or medical marijuana and pursuant to that order, the selection, measuring, compounding, labeling or packaging necessary to prepare the prescription or order for delivery.

“Dispensary” means any location that does not meet the definition of “collective” or “collective garden” and in which medical marijuana or medical cannabis is processed, dispensed, selected, measured, compounded, packaged, labeled, sold, bartered or given away to any member of the public. It also includes any vehicle or other mode of

transportation, stationary or mobile, which is used to transport, distribute, deliver, sell or give away medical cannabis or medical marijuana to any member of the public, including members of cooperatives as defined in RCW 69.51A.250.

“Marijuana” has the meaning provided in RCW 69.50.101.

“Marijuana concentrates” has the meaning provided in RCW 69.50.101.

“Marijuana infused products” has the meaning provided in RCW 69.50.101.

“Marijuana retailer” has the meaning provided in RCW 69.50.101.

“Marijuana processor” has the meaning provided in RCW 69.50.101.

“Marijuana producer” has the meaning provided in RCW 69.50.101.

“Marijuana retailer with a medical marijuana endorsement” has the meaning provided in RCW 69.51A.010.

“Marijuana infused products” has the meaning provided in RCW 69.50.101.

“Medical use of marijuana” has the meaning provided in RCW 69.51A.010.

“Qualifying patient” has the meaning provided in RCW 69.51A.010.

“Usable marijuana” has the meaning provided in RCW 69.50.101.

Section 3. Section 20.09.030 of the Pacific Municipal Code is hereby amended to read as follows:

20.09.030 Prohibited activities.

A. It is unlawful to own, establish, operate, use or permit the establishment or operation of a medical marijuana dispensary, or to participate as an employee, contractor, agent or volunteer or in any other manner or capacity in any marijuana business, even if the same is licensed by the State of Washington. ~~That does not have a license from the Liquor Control Board of the state of Washington.~~

B. It is unlawful to own, establish, operate, use, participate in or permit the establishment or operation of a medical marijuana collective garden or a cooperative, or to participate as an employee, contractor, agent

or volunteer or any other manner or capacity in any collective garden or cooperative, even if the same is licensed/registered with the State of Washington

C. It is unlawful to lease, rent, or otherwise allow any medical marijuana dispensary, or any medical marijuana collective garden or any cooperative, outdoors, indoors, in any building, structure, premises, location or land in the City, even if the same is licensed/registered with the State of Washington.

Section 4. Section 20.09.040 is hereby amended to read as follows:

20.09.040 Use not permitted in any zone. The use of any building, structure, location, premises or land for a medical marijuana dispensary or a collective garden or a cooperative is not ~~currently~~ allowed in the City and medical marijuana dispensaries and collective gardens and cooperatives are not permitted uses in any zone. So long as this chapter remains in effect, the City shall not determine, either through interpretation or otherwise, that the use of any building, structure, location, premises or land as a medical marijuana dispensary, or collective garden or cooperative may be permitted in any zone.

Section 5. Section 20.09.050 is hereby amended to read as follows:

20.09.050 No vested or nonconforming rights. This chapter prohibits medical marijuana dispensaries, ~~and~~ collective gardens and cooperatives. Neither this chapter nor any other City ordinance, City action, failure to act, statement, representation, certificate, approval or permit issued by the City or its departments, or their respective representatives, agents, employees, attorneys or assigns, shall create, confer, or convey any vested or nonconforming right or benefit regarding any medical marijuana business, marijuana business, cooperatives or collective garden.

Section 6. Findings. The Council adopts all of the “whereas” sections of this

Ordinance as findings to support this interim zoning ordinance, as well as the following:

A. The purpose of this interim zoning ordinance is to maintain the status quo while the City drafts and considers amendments to chapter 20.09 of the Pacific Municipal Code, relating to medical marijuana, addressing definitions and the prohibition on a new use created by the Washington State Legislature, or “cooperatives” (under RCW 69.51A.250. The Legislature is eliminating “collective gardens” under RCW 69.51A.085 (to be effective up to July 1, 2016), and replacing them with “cooperatives” under RCW 69.51A.250 (effective beginning on July 1, 2016).

B. The City will consider adoption and enforcement of an ordinance addressing cooperatives under RCW 69.51A.250 during the next six months, while this interim zoning ordinance is in effect.

C. During the period of time that this interim zoning ordinance is in effect, the City will also consider the manner in which the negative impacts and secondary effects associated with cooperatives (on-going or predicted) in the City can be ameliorated, including but not limited to, the demands that will be placed upon scarce City policing, legal, policy and administrative resources; neighborhood disruption, increased transient visitors and intimidation; the exposure of school-age children and other sensitive residents to marijuana, illegal sales to both minors and adults; fraud in issuing, obtaining or using medical marijuana prescriptions, murders, robberies, burglaries, assaults, drug trafficking and other violent crimes.

D. The State of Washington has adopted a new regulatory and enforcement system to address cooperatives, but no licenses have yet issued, and so there is no way to determine whether (or the manner in which) the State will enforce these rules. The Council also acknowledges that the State has not performed any environmental analyses that will assist cities, towns and counties in the adoption of local regulations addressing marijuana uses, and that municipalities must therefore either develop their own analyses or observe these impacts after-the-fact (or, *after* these marijuana uses locate and begin operation in cities, towns and counties throughout Washington.) Then, the municipalities will be required to “fix” the problems stemming from these uses with their already scarce resources.

E. In sum, the City Council believes that it cannot adopt legislation to address the negative environmental impacts and secondary land use effects of medical marijuana cooperatives until the extent of these impacts are known, and there is strict enforcement of these laws.

F. No part of this interim ordinance is intended to or shall be deemed to conflict with federal law, including but not limited to, the Controlled Substances Act, 21 U.S.C. Section 800 *et seq.*, the Uniform Controlled Substances Act (chapter 69.50 RCW) nor to otherwise permit any activity that is prohibited under either Act, or any other local, state or federal law, statute, rule or regulation. This interim ordinance is not intended to address or invite litigation over the question whether the State of Washington’s medical or recreational marijuana laws (or this City’s laws) satisfy the federal government’s enforcement priorities. Nothing in this interim ordinance shall be construed to supersede Washington state law prohibiting the acquisition, possession, manufacture, sale or use of medical cannabis or recreational marijuana in any manner not authorized by chapter 69.51A RCW or chapter 69.50 RCW. Nothing in this interim ordinance shall be construed to supersede legislation prohibiting persons from engaging in conduct that endangers others, or that creates a nuisance, as defined herein. It is the intention of the City Council that this interim ordinance be interpreted to be compatible with federal and state enactments and in furtherance of the public purposes that those enactments encompass.

Section 7. Interim Ordinance Adopted. This interim ordinance is immediately adopted for a period of six months in order to provide the City adequate time to:

A. Study the secondary land use impacts associated with the location and siting of structures and uses in which medical marijuana cooperatives may take place. This includes, but is not limited to, all activities associated with medical marijuana, including individual cultivation, collective gardens, cooperatives, production, processing, transfer, bartering, exchange and delivery of marijuana between qualified patients, designated providers or anyone else. This work will begin upon adoption of this ordinance and is expected to take three months.

B. Allow the City adequate time to study the effects of state licensed marijuana uses as they operate in other areas (throughout Washington, Colorado and other states adopting similar laws). This work will begin upon adoption of this ordinance and is expected to take three months.

C. Draft an ordinance addressing medical marijuana cooperatives in the City. This work will begin immediately after the activities described in A and B of this Section are complete.

D. Hold a public hearing(s) on the draft ordinance, obtain public input on such ordinance, allow the Planning Commission to make recommendations to the City Council, for the City Council to review the draft ordinance and, if desired, to adopt new regulations or prohibitions on marijuana uses. This work will begin immediately after the activities described in A, B and C are complete.

Section 8. Effect of Interim Zoning Ordinance. The City Council imposes an immediate six-month prohibition on the acceptance of all development permit and business license applications for any structure, use or operation involving medical marijuana cooperatives, as the same are defined in this Ordinance and RCW 69.51A.250. All such development permit and business license applications shall be rejected and returned to the applicant.

Section 9. Duration of Interim Zoning Ordinance. This interim zoning ordinance shall commence on the effective date set forth in Section 15 herein. As long as the City holds a public hearing on the interim zoning ordinance and adopts findings and conclusions in support of the interim zoning ordinance (as contemplated by Section 6 herein), the interim zoning ordinance shall not terminate until six (6) months after the date of adoption, or at the time all of the events described in Section 3 have been accomplished, whichever is sooner. The Council shall make the decision to terminate the moratorium by ordinance, and termination shall not otherwise be presumed to have occurred.

Section 10. Public Hearing on Interim Zoning Ordinance. Pursuant to RCW 36.70A.390 and RCW 35.63.200, the City Council shall hold a public hearing on this interim zoning ordinance within sixty (60) days of its adoption, or before _____, 2016. The Council hereby schedules this hearing for

_____, 2016. During the next Council meeting immediately following, the City Council shall adopt findings of fact on the subject of this interim zoning ordinance and either justify its continued imposition or repeal this ordinance.

Section 11. Declaration of Emergency.¹ The City Council hereby declares that an emergency exists necessitating that this interim zoning ordinance take effect immediately upon passage by a majority vote plus one of the whole membership of the Council, and that the same is not subject to a referendum.² The new regulations for cooperatives in RCW 69.51A.250 will be effective on July 1, 2016. Therefore, applications for this use could be submitted to the state cannabis and liquor board on or before this date. Under RCW 69.51A.250(3)(c), no cooperative can be located where prohibited by a city zoning provision, and the state liquor and cannabis board “must deny the registration of any cooperative if the location does not comply with the requirements set forth in [RCW 69.51A.250(3)].”

The process for adoption of a development regulation, as outlined in this Ordinance will usually take about 2-3 months, depending on the schedule of the Planning Commission and City Council. The City needs to adopt this interim zoning ordinance to be effective immediately, in order to prevent the state liquor and cannabis board from approving applications for medical marijuana collectives in the City of Pacific. Also, immediate adoption is required to ensure that applications for development and business licenses cannot be submitted to Pacific and possibly become vested, leading to development that could be incompatible with the regulations eventually adopted by the City (after the process described herein). Therefore, the interim zoning ordinance must be adopted immediately as an emergency measure to protect the public health, safety and welfare.

Section 12. Severability. If any section, sentence, clause or phrase of this Ordinance should be held to be unconstitutional or unlawful by a court of competent jurisdiction, such invalidity or unconstitutionality shall not affect the validity or constitutionality of any other section, sentence, clause or phrase of this Ordinance.

Section 13. Publication. This Ordinance shall be published by an approved summary consisting of the title.

Section 14. Copies of Relevant Statutes Adopted by Reference. Pursuant to RCW 35A.12.140, one copy of RCW 69.51A.010 and 69.50.101 are filed in the office of the City Clerk for examination by the public.

Section 15. Effective Date. (if the Council desires immediate adoption and there is a vote of a majority plus one of the entire council): This Ordinance shall take effect and be in full force immediately upon passage, having received the vote of a majority plus one of the entire Council.

¹ If the City does not have sufficient votes to pass this ordinance on an emergency basis, this section should be deleted. Without a majority plus one of the full membership of the Council, the ordinance would go into effect at the usual time. See, RCW 35A.12.130 for code cities.

RCW 69.51A.250

Cooperatives—Qualifying patients or designated providers may form—Requirements—Restrictions on locations—State liquor and cannabis board may adopt rules. (*Effective July 1, 2016.*)

*** CHANGE IN 2016 *** (SEE [2520.SL](#)) ***

(1) Qualifying patients or designated providers may form a cooperative and share responsibility for acquiring and supplying the resources needed to produce and process marijuana only for the medical use of members of the cooperative. No more than four qualifying patients or designated providers may become members of a cooperative under this section and all members must hold valid recognition cards. All members of the cooperative must be at least twenty-one years old. The designated provider of a qualifying patient who is under twenty-one years old may be a member of a cooperative on the qualifying patient's behalf.

(2) Qualifying patients and designated providers who wish to form a cooperative must register the location with the state liquor and cannabis board and this is the only location where cooperative members may grow or process marijuana. This registration must include the names of all participating members and copies of each participant's recognition card. Only qualifying patients or designated providers registered with the state liquor and cannabis board in association with the location may participate in growing or receive useable marijuana or marijuana-infused products grown at that location.

(3) No cooperative may be located in any of the following areas:

(a) Within one mile of a marijuana retailer;

(b) Within the smaller of either:

(i) One thousand feet of the perimeter of the grounds of any elementary or secondary school, playground, recreation center or facility, child care center, public park, public transit center, library, or any game arcade that admission to which is not restricted to persons aged twenty-one years or older; or

(ii) The area restricted by ordinance, if the cooperative is located in a city, county, or town that has passed an ordinance pursuant to RCW [69.50.331](#)(8); or

(c) Where prohibited by a city, town, or county zoning provision.

(4) The state liquor and cannabis board must deny the registration of any cooperative if the location does not comply with the requirements set forth in subsection (3) of this section.

(5) If a qualifying patient or designated provider no longer participates in growing at the location, he or she must notify the state liquor and cannabis board within fifteen days of the date the qualifying patient or designated provider ceases participation. The state liquor and cannabis board must remove his or her name from connection to the cooperative. Additional qualifying patients or designated providers may not join the cooperative until sixty days have passed since the date on which the last qualifying patient or designated provider notifies the state liquor and cannabis board that he or she no longer participates in that cooperative.

(6) Qualifying patients or designated providers who participate in a cooperative under this section:

(a) May grow up to the total amount of plants for which each participating member is authorized on their recognition cards, up to a maximum of sixty plants. At the location, the qualifying patients or designated providers may possess the amount of useable marijuana that

can be produced with the number of plants permitted under this subsection, but no more than seventy-two ounces;

(b) May only participate in one cooperative;

(c) May only grow plants in the cooperative and if he or she grows plants in the cooperative may not grow plants elsewhere;

(d) Must provide assistance in growing plants. A monetary contribution or donation is not to be considered assistance under this section. Participants must provide nonmonetary resources and labor in order to participate; and

(e) May not sell, donate, or otherwise provide marijuana, marijuana concentrates, useable marijuana, or marijuana-infused products to a person who is not participating under this section.

(7) The location of the cooperative must be the domicile of one of the participants. Only one cooperative may be located per property tax parcel. A copy of each participant's recognition card must be kept at the location at all times.

(8) The state liquor and cannabis board may adopt rules to implement this section including:

(a) Any security requirements necessary to ensure the safety of the cooperative and to reduce the risk of diversion from the cooperative;

(b) A seed to sale traceability model that is similar to the seed to sale traceability model used by licensees that will allow the state liquor and cannabis board to track all marijuana grown in a cooperative.

(9) The state liquor and cannabis board or law enforcement may inspect a cooperative registered under this section to ensure members are in compliance with this section. The state liquor and cannabis board must adopt rules on reasonable inspection hours and reasons for inspections.

The following job description is designed to outline the functions and position requirements for the Storm Water Technician. It does *not* identify all tasks that may be expected, nor does it address every performance standard that must be maintained.

General Position Summary:

Under the supervision of the Public Works Manager and acting in concert with the Water / Stormwater Manager, perform a variety of technical and administrative tasks to support and coordinate compliance with the Municipal Stormwater NPDES Phase II Program which governs stormwater permits, discharges, and related environmental regulatory requirements.

The employee in this position provides assistance to citizens and staff with regards to stormwater and water quality; including inspection of construction stormwater sites and enforcement of the City's stormwater control ordinance and adopted Stormwater Manual, inspection of public and private storm facilities; implementation of policies, procedures associated with stormwater management, and Stormwater Pollution Prevention Plan for municipal operations and maintenance; and other related tasks. The Stormwater Technician is often the 'face of the City' providing initial customer contact.

Essential Functions/Major Responsibilities:

- Under direction, implements the City's Illicit Discharge Detection and Elimination (IDDE) program (PMC 24.08.120) including responding to complaints, conducting field inspections and water quality monitoring of watercourses and other stormwater facilities.
- Documents stormwater code violations (PMC 24.08 and Adopted Stormwater Manual), issuing written correspondence, notices of violation and performs other enforcement activities to ensure code compliance.
- Develops and maintains computer inventory of drainage facilities and drainage problems on databases or spreadsheets, updates mapping information and files, and uses data to analyze storm drainage issues.
- Assists in implementing the City's Construction Site Runoff Control program (PMC 24.08) including reviewing stormwater pollution prevention plans, conducting field inspections of construction sites, evaluating effectiveness of erosion control measures, documenting code violations, and following up to ensure code compliance.
- Assists with implementing of City's Post-construction Stormwater Management program (PMC 24.08 and Adopted Stormwater Manual) including scheduling, performing, and following up on inspections of private and public storm drainage systems.
- Assists with maintaining tracking system(s) for various components of the NPDES Permit, and in preparing NPDES Annual Reports.
- Provides information to the public, other City departments, contractors and interested parties regarding the Pacific Municipal Code and related stormwater regulations,

stormwater best management practices (BMPs), water quality issues and city programs and policies.

- Meet with citizens and business owners to arrange for inspections; inspect private and public detention/drainage systems and maintain related databases; prepare reports or correspondence to obtain compliance with regulations.
- Coordinate with Public Works Program Coordinator to develop and implement stormwater inspection and maintenance standards and schedules.
- Serves as a liaison between the Public Works Division and other City divisions and departments (i.e. Engineering, Planning, etc.)
- Responds to complaints from the public in a variety of methods to include written replies and discussions.
- Prepares reports, documents inspections, issues letters; photographs property conditions and maintains required records. Uses a computer database and/or spreadsheets, GPS and computer mapping for reporting and record keeping.
- Work as part of the Public Works maintenance crew on small stormwater projects, such as, but not limited to storm water debris removal, BMP installation, and catch basin frame and grate repair, culvert cleaning and replacement and replacement.
- Provide public outreach and education to the general public and target groups regarding maintenance of stormwater facilities and BMPs and stormwater best management practices and solicit input as appropriate.
- Perform other related duties and responsibilities as required.

Secondary Functions:

- Attends meetings to provide information and assistance in resolving issues related to stormwater and related issues.
- Performs basic design and reviews construction plans for stormwater compliance.
- Because of the small size of the City’s Public Works Department ~~staffing level~~, the employee in this job classification is expected to perform a wide range of duties, as may be required in order to support facilities, fleet, parks, streets, and water and wastewater operations and maintenance activities.

Job Scope: The Stormwater Technician job involves recurring work situations with occasional variations from the norm and a moderate degree of complexity. The Stormwater Technician works from established procedures under minimal to moderate direct supervision with some regular work verification. Errors in work can cause a disruption of utility services, property damage and/or personal injury.

Portions of the City’s TIP which meet the criteria for regionally significant projects are then incorporated into the Statewide Transportation Improvement Program (STIP). The TIP is an important tool for local, state and federally funded projects, and is utilized by governmental and planning organizations at all levels. Projects must be identified on the TIP and/or the STIP to be eligible for funding from Federal and State sources. A Public Hearing is required.
