ORDINANCE NO. 12- 1832

AN ORDINANCE OF THE CITY OF PACIFIC, WASHINGTON, AMENDING PACIFIC MUNICIPAL CODE SECTION 5.02.045 AND SECTION 5.02.080 REGARDING BUSINESS LICENSES TO (1) PROVIDE THAT NON-PROFIT AND NOT FOR PROFIT BUSINESSES BE REQUIRED TO HAVE A CURRENT BUSINESS LICENSE WITH THE CITY AND (2) TO REQUIRE EACH BUSINESS AT A LOCATION TO HAVE A SEPARATE BUSINESS LICENSE.

NOW THEREFORE, THE CITY COUNCIL OF PACIFIC, WASHINGTON DOES ORDAIN AS FOLLOWS:

(Repealed language is noted by strike through and new language is italicized)

**Section 1.** Pacific Municipal Code 5.02.045 is amended as follows:

**5.02.045 Exemptions:** The license requirements of this chapter shall not apply to religious, charitable or benevolent societies or organizations. *Non-profit and not for profit agencies/businesses must have a current business license with the City. This business license will be provided at no charge to the non-profit and not for profit business/agency.*

**Section 2.** Pacific Municipal Code 5.02.080 is amended as follows:

**5.02.080 Joint Licenses:** *Each business that has a Unified Business Identifier (UBI) number with the State of Washington must obtain a city business license. A person conducting multiple engaged in two or more businesses at the same location shall not be required to obtain separate licenses for conducting each of such businesses but, when eligible, shall be issued one license which shall specify on its face all such businesses. be required to obtain a city business license for each business that has a unique UBI number.*

**Section 3.** Severability.


If any section, sentence, clause or phrase of this ordinance should be held to be invalid or unconstitutional by a court of competent jurisdiction, such invalidity or unconstitutionality shall not affect the validity or constitutionality of any other section, sentence, clause or phrase of this ordinance.

**Section 4.** Effective Date.


This Ordinance shall be published in the official newspaper of the City and shall take effect and be in full force five days after the date of publication.


