ORDINANCE NO. 1812**

**AN ORDINANCE OF THE CITY OF PACIFIC, WASHINGTON, AUTHORIZING PROPERTY TAXES TO BE LEVIED AND FIXING THE AMOUNT OF TAXES TO BE LEVIED FOR THE CITY OF PACIFIC FOR THE YEAR 2012; PROVIDING FOR SEVERABILITY; AND ESTABLISHING AN EFFECTIVE DATE**

**WHEREAS**, the City Council of the City of Pacific after hearing and after duly considering all relevant evidence and testimony presented, determined that the City of Pacific required a regular levy in the amount of \$848,381, which does not include an increase in property tax revenue from the previous year, and amounts resulting from the addition of new construction and improvements to property and any increase in the value of state-assessed property, and amounts authorized by law as a result of any annexations that have occurred and refunds made, in order to discharge the expected expenses and obligations of the district and in its best interest; ;

**NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF PACIFIC, WASHINGTON, DO ORDAIN AS FOLLOWS:**

**Section 1. Levy Increase Authorized.** That an increase in the regular property tax levy is hereby authorized for the 2012 levy in the amount of \$0 which is a percentage increase of 0% from the previous year. This increase is exclusive of additional revenue resulting from the addition of new construction and improvements to property and any increase in the value of state assessed property, and any additional amounts resulting from any annexations that have occurred and refunds made.

**Section 2. Notification.** The Finance Director is directed to certify the dollar amount and to transmit the certification of same by certified mail to King and Pierce County Councils and to King and Pierce County Assessors immediately upon passage.

**Section 3. Severability.** Should any section, paragraph, sentence, clause or phrase of this ordinance, or its application to any person or circumstance, be declared unconstitutional or otherwise invalid for any reason, or should any portion of this ordinance be pre-empted by state or federal law or regulation, such decision or pre-emption shall not affect the validity of the remaining portions of this ordinance or its application to other persons or circumstances.

**Section 4. Effective Date.** This ordinance shall be in full force and take effect five (5) days after its publication according to law.


